NYSAC Counsel – Patrick Cummings, Esq.

- This is amazing venue.
- Lobbying for the Counties.
- Budget is typically passed by April 1st. has not happened yet. Delayed 1. Power control, who gets control of that the Governor and legislature. 2. Major issues housing (out of budget) 3. Bail reform. 4. Indigent Defense 18b counsel going up. \$75 up to \$130 to \$160 Counties to pick up the first \$25. State will pick the rest up. 5. eFMAP \$600- billion dollars. Budget taking it away. Everyone has made it clear this cannot happen. Keep your voice up on this. Budget will be resume in June anticipating. Delinquent Taxes foreclosures supreme court case going on fiscal relief. Anticipating taking out of the budget state changing unilaterally NYSAC working on with state to keep this moving forward. Sales Tax over 10% average better than last year. Need to ask for a home rule over 7.5 -8 cents goes to the county. Extenders 2 years going forward. They have to pass by June. Get your home rules in.
- Since the budget has not been passed by April 1, then they issue extenders. June is the last they will be in office, but could potentially come back.
- Shelley Stein (Genesee) Several years ago HCR (funding partner) participated in Brownfield Cleanup Site for apartments in the City of Bataiva. Due to the impact of inflation. Rising wages at an incredible pace. Housing units now falls under section 8 and not for workforce entry. Lenny is not wanting to talk to Genesee County about this. Important workforce development, we have jobs, our goal was to match for the workforce to come into the City of Batavia, now it does not fit the original agenda. Patrick to look into this issue.
- Finding these problems pre-covid contracts and now working after covid. Thruway Green Apple going up along 1-90 but now seeing issues with finalizing because of several reasons (lack of supplies, covid, etc.)
- Reserves healthy with the State. Higher income tax level over 2 billion dollars. Money is there from the State to help counties.
- Yates County eFMAP reconcile money not received from 2016,- don't expect a check anytime soon, presuming there will be lawsuits is Patrick's guess.
- Shelley Stein Genesee County— explain one party rule in Albany? Patrick— one piece of legislation. Unique the governor has veto power. Over last 12 years more policy put in. Controlled by the executive. Policy control by governor which pushes into the budget. Control how the bill is done and take that away from legislature. Interparty power dynamics.
- Brooke Harris Allegany County ARPA funds strong suggestion from NACO Patrick has not seen this. Take it seriously.
- Leslie Church Yate County Comptroller put report out on sales tax on marijuana. In just some areas. Will be pretty quick as they come in. Will local government be notified of when a license has been provided in your community?
- Tom Sweet Chemung County a marijuana store in Binghamton is losing business because of the sticker stores. Bills out there that will increase the felonies.

Congressman Nick Langworthy (zoom video)

- Thank you for what you do.
- Goal best federal partner to our local governments and municipalities. Your needs and concerns are important. Will do what he can do to enforce your needs and concerns.
- Burden of NYS mandates have made it very difficult. Trying to keep clean balance sheets and accomplishing things for your constituents.
- Budget delayed three weeks already.
 - eFMAP: counties are going to force to flip the bill here.
 - Spending sprees just not right.
 - Unfair and illegal seizure of funds
 - Working with Congressmembers Tenney and Williams to get some awareness and attention to get the funds to go where they are supposed to go.
 - Held a lot of meetings, broadband, agricultural administration priorities. Need quick action for the funds. Leaders need to work with Economic Development. Losing many to economic issues here in NYS. Work on realistic opportunities without massive expenditures. Governor debt ceiling bill. 10 trillion dollars debt. Need to get spending under control. This pandemic is over. Our bill does state our position bring Senate and Governor together. "Limit, Save and Grow". 500 billion dollars on student bail out. 50-60 billion unspent covid funds. They are on balance sheet, need to help clear this debt.
 - Energy plans state taking down the wrong path. The technology does not exist. Our energy suppliers cannot provide the energy needed for the governor's plan to go all electric. Blizzard this Dec. 2022 many would have froze if they lived off electric.
 - Shelley Stein (Genesee) We need employees, pathway for our farm workers those are the ones that provide food to all. Farm Bill was not main topic but for the farm workers to have the surety, safe predictable work force. A solution should come forward. Not take the path of the immigration rules that are inhabiting potential farmers.
 - Tom Sweet Chemung Energy independent. Not true anymore. China is ruining our dollar. Pipe lines shut down by Biden. Gas skyrocketed. HR1 all about energy.
 - Solar Fields and windmills China is integrated everywhere. This is a true problem. China wants to replace our wealth. Need to start at State levels to ban these energy issues. Very concern of the threat of Chinese. Deadly fentanyl that Chinese distributing through the cartel.
