SECTION 1: LEGISLATIVE INTENT. It is the intent of the within Local Law to establish the office of County Attorney as a full-time position requiring dedication of whole time to the duties of that position.

SECTION 2: FULL-TIME DESIGNATION. The County attorney shall give whole time to the duties of the office and shall not otherwise engage in the practice of law, act as an arbitrator, referee or compensated mediator in any action or proceeding or matter or engage in the conduct of any other profession or business which interferes with the performance of duties as County Attorney.

SECTION 3: EFFECTIVE DATE. The designation of full-time status of the position of County Attorney shall be effective in 1995 upon the filing of an acceptance of designation as full-time by the incumbent appointed to the position of County Attorney. Said filing shall be made with the Clerk of the Steuben County Legislature and the Personnel Officer. The position shall thereafter be designated full-time.

SECTION 4: COMPENSATION. The compensation for the position of County Attorney shall be \$82,500.00 per annum, pro-rated as of the date of filing of the acceptance of designation by the incumbent County Attorney. An incumbent in the position of County Attorney shall receive such benefits of employment as are granted to other members of management and appointed department heads and shall have leave accruals credited, taking into consideration duration of employment. The Administrative Committee of the Steuben County Legislature shall cause such accruals to be credited following the filing of the acceptance of designation of full-time status.

SECTION 5: EFFECTIVE DATE. This local law shall become effective subject to a permissive referendum, forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.




