SECTION 1: LEGISLATIVE INTENT

It is the intent of the within Local Law to place the Commissioner of Public Works in the unclassified service of the Civil Service. It is further intended to acknowledge the creation of a position or positions of Deputy Public Works Commissioner, subject to further approval and legalizing act or acts of the County Legislature.

SECTION 2: AMENDING LOCAL LAW NO. FIVE FOR THE YEAR 1987

Local Law No. Five for the Year 1987 be, and the same hereby is, amended to read as follows:

SECTION 3. APPOINTMENT, TERM, SALARY OF COMMISSIONER OF PUBLIC WORKS

The Department of Public Works of the County of Steuben shall be under the direction of the Commissioner of Public Works.

- (a) The Commissioner of Public Works shall be appointed by the Steuben County Legislature, and shall be directly responsible to the Steuben County Legislature.
- (b) The Commissioner of Public Works shall be in the unclassified service of the Civil Service.

SECTION 6. DEPUTIES AND STAFF APPOINTMENTS

- (a) Commissioner of Public Works shall appoint such assistants and members of the Department of Public Works' staff as may be authorized by the Steuben County Legislature. All persons so appointed shall be directly responsible to the Commissioner of Public Works.
- (b) The Commissioner may, with the approval of the County Legislature, appoint for a term not extending beyond the term of office of said County Commissioner of Public Works, and at pleasure remove, a Deputy Commissioner of Public Works to serve at such compensation as may be fixed from time to time by the County Legislature. Such Deputy shall act generally for and in place of the Commissioner.

SECTION 3:

Nothing contained herein shall limit the appointment or term of office or otherwise modify the term, appointment or compensation of the incumbent Commissioner of Public Works.

SECTION 4: EFFECTIVE DATE

This Local Law shall take effect immediately upon passage.
