SECTION 1. The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed for and in consideration of the sum of One Dollar (\$1.00) to convey to Julius Hauser and Jadwiga Hauser the following tract of land:

ALL THAT TRACT OR PARCEL OF LAND, being a portion of Great Lot 34 in Township 4 of the fifth Range of Townships, situated in the Town of Fremont, County of Steuben, State of New York bounded and described as follows:

Commencing at a point in the center of County Route 70-A at a distance of 1295.2 \pm feet measured westerly along the center of County Route 70-A from its intersection with the center of the Hungry Hollow Town Road;

Thence S02°16′04"W along the division line between the properties of the Steuben County Welfare Department, now or formerly, (L.602, Pg. 314) and Ellis (L.1117, Pg. 348) in part, and the County of Steuben by virtue of Map #6.20 (L.415, Pg. 327) and Ellis (L.1117. Pg. 348) in part, a distance of 194.40 feet to an iron pin set at the point of beginning of the parcel to be conveyed;
