Local Law No. TEN of the year 19 84

A local law Amending Local Law No. 2 for the Year 1979 providing for an exemption from taxation and special ad valorem levies imposed by the County of Steuben for County and Part-County purposes.

SECTION 1. LEGISLATIVE INTENT

It is the intent of the within Local Law to reduce the exemption from taxation and special ad valorem levies granted to "eligible business facilities" as defined in Section 115 of the Commerce Law of the State of New York from 100% total exemption, as is presently provided by Local Law No. 2 of the Year 1979 to 50% total exemption from taxation and special ad valorem levies.

SECTION 2. AMOUNT OF EXEMPTION

A 50% total exemption from taxation and special ad valorem levies for ten successive years after the adoption of Local Law No. 2 of the Year 1979 is hereby granted to "eligible business facilities" as defined in Section 115 of the Commerce Law of the State of New York, located in this County, from taxes and special ad valorem levies imposed by or in behalf of Steuben County for county and part-county purposes.

SECTION 3. EXISTING ELIGIBLE BUSINESS FACILITIES

Nothing contained in this within Local Law shall be deemed applicable or construed to reduce the exemption from taxation and special ad valorem levies for existing Certificates of Eligibility granted to eligible business facilities.

SECTION 4. EFFECTIVE DATE

The within Local Law shall be effective immediately upon passage.
