SECTION 1: LEGISLATIVE INTENT - The purpose of this local law is to amend Local Law No. Five for the Year 1984 to provide for sealed bids of a certain parcel or parcels of delinquent tax property.

SECTION 2: AMENDMENT OF LOCAL LAW NO. FIVE FOR THE YEAR 1984 - SECTION 7

Local Law No. Five for the Year 1984, Section 7 be, and the same hereby is, amended to read as follows:

SECTION 7:

"Following the issuance of a tax deed to the County of Steuben for taxes owing on any parcel, the Treasurer, with the advice and consent of the Finance Committee of the Steuben County Legislature, may determine that an individual parcel or parcels should not be offered for sale at public auction and may be advertised by sealed bid. Said parcel or parcels so removed from public auction shall be for such purposes as, but not limited to, avoidance of additional expenses for repair due to the condition of the dwelling and to otherwise protect and serve the health and welfare of the public. The County shall award the sale of the subject property to the highest bid received or may reserve the right to reject all bids as unsatisfactory. The issuance of the deed for said parcel removed from public sale shall be subject to the final vote of the Steuben County Legislature."




